Violation of these rules may result in The SCOREHL losing its ice time, thus threatening the viability of the League. Players violating the above rule will be suspended and/or banned from the League with <u>no</u> <u>refund of fees</u>.

Also, any player under the influence of any drug or alcohol and deemed unfit to play, will be removed from the starting lineup before the game by either their captain, the league officials or the attending on-ice referees and will not be permitted to play.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I have paid my registration fee for membership and participation in the SCOREHL. I accept that hockey is a sport with inherent risks and that participation in the sport may result in my injury. I AGREE TO ACCEPT THE RESPONSIBILITY FOR MY OWN SAFETY.

In consideration of my membership and participation in the SCOREHL, I HEREBY AGREE AS FOLLOWS:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the SCOREHL, League organizers, team captains, referees, the Corporation of the City of Barrie and the Corporation of the Township of Essa (all of whom are herein after collectively referred to as the "League");
- 2. TO RELEASE THE LEAGUE from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in the League and League sponsored activities, due to any cause whatsoever, including negligence on the part of the League;
- 3. TO HOLD HARMLESS AND INDEMNIFY THE LEAGUE (including its administrators) for any losses or damages incurred, including sickness or death that occurs as a result of the COVID 19 VIRUS and agrees to release the City of Barrie, Township of Essa and the SCOREHL (including its administrators) from any liability in connection therewith and further agrees to indemnify and hold harmless the City of Barrie, Township of Essa and SCOREHL (including its administrators) from any claim that may be made by anyone, against the City of Barrie, Township of Essa and Molson Sportsmen League in connection therewith.
- 4. TO HOLD HARMLESS AND INDEMNIFY THE LEAGUE from any and all liability for any property damage or personal injury to any third party, resulting from my participation in the League and League sponsored activities;
- 5. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.
